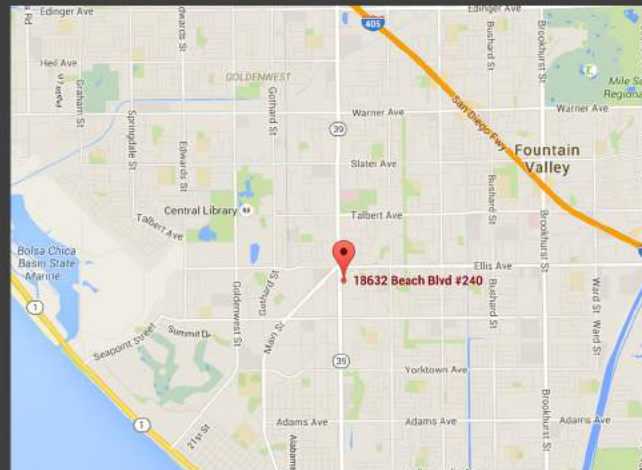

Treatment Options include:

Treatment services are an accumulation of individualized counseling, group counseling, drug and alcohol education, drug testing, and different therapies which accumulated are called addiction treatment. Depending on the client's need, the individual can either have a full schedule, which is all day from 9 am until 3:00 pm Monday thru Friday or a partial schedule, which can be a few days per week down to a few hours per month. In some instances, individuals are under the care of a doctor for their detoxification medication and are eligible for outpatient treatment services simultaneously. Our treatment program consist of:

- One-on-One Case Management
- One-on-One Counseling
- Group Counseling
- Addiction Education
- Relapse Prevention Groups
- Life Skills Training
- Monthly Family Groups
- Dual Diagnosis Treatment
- Introduction to 12-Step self-help groups
- Structured Sober Housing
